Warrant

THE STATE OF NEW HAMPSHIRE

To the Inhabitants of the Town of Colebrook, in the County of Coos, in the State of New Hampshire, qualified to vote in town affairs:

You are hereby notified to meet at the Town Hall in said Town of Colebrook, on Tuesday, the 13th day of March, next, at ten o'clock in the forenoon to act upon the following subjects:

1. To bring in your ballots:
 - a. For the election of all Town Officers to be elected by ballot for the Town of Colebrook for the ensuing year.
 - b. To act upon all other following articles contained in this Warrant.
2. To see if the Town will instruct its Selectmen to appoint all other Town Officers as required by law.
3. To see if the Town will vote to approve Town Charges as shown by the Budget and raise money for the payment of same.
4. To raise such sums of money as may be necessary for the support of the Poor.
5. To raise such sums of money as may be necessary for the support of the Town Library.

6. To raise such sums of money as may be necessary for the construction of Highways and Bridges.
 - a. To see what sums of money the Town will raise and appropriate for summer and winter maintenance for Town Roads for 1951.
 - b. To see if the Town will raise the sum of \$780.49 for maintenance, construction, or reconstruction of Class V Highways, in which event the State will contribute \$3,121.96.
7. To see what sum of money the Town will vote to raise for new road equipment, and to authorize the Selectmen to trade in any old equipment they feel to be in the best interests of the Town.
8. To see if the Town will vote to remove the snow from the business area of the village, defining the area to be cleared, and to raise money for the same.
9. To see what sums of money the Town will vote to raise for tarring streets.
10. To see what sums of money the Town will vote to raise:
 - a. For the construction and repair of sidewalks.
 - b. For the plowing and sanding of sidewalks.
11. To see what sums of money the Town will raise for sewer maintenance.
12. To raise such sums of money as may be necessary for Police.
13. To raise such sums of money as may be necessary for the care of Cemeteries.

14. To see if the voters of the Town of Colebrook will instruct the Selectmen to take appropriate action and enforce same in regard to the restraint of dogs according to their authority under the Statutes of the State of New Hampshire.
15. To see what sum of money the Town will vote to raise for purposes of Civilian Defense.
16. To see if the provisions of Chapter 171-A of the Revised Laws relative to playing Beano shall be adopted in Colebrook.
17. To see what sum of money the Town will vote to raise toward the maintenance of a free skating rink.
18. To see if the Town will vote to raise the sum of \$1,500 for hydrant rental for the ensuing year.
19. To see what sum of money the Town will raise and appropriate for expenditures by the Chamber of Commerce for advertising the Town of Colebrook or otherwise promoting the resources and welfare of the town.
20. To see if the Town will vote to raise the sum of \$300 for the observance of Memorial Day and the care of the monument lots.
21. To see if the Town will vote to give free use of the Town Hall to Public Schools in said Town, for school purposes, including heat, lights and janitor's services, whenever such does not conflict with the best interests of the Town, for the year next ensuing.
22. To see if the Town will vote to raise and appropriate the sum of \$200 to the White Mountains Region Association, for the purpose of issuing and distributing printed matter, newspaper and magazine advertising, and otherwise calling attention to the resources and ad-

vantages of the Town, in cooperation with the other 45 towns in the White Mountain Region.

23. To see if the Town will vote to authorize the Selectmen to borrow money to defray the expenses of the Town in anticipation of taxes, for the year next ensuing.
24. To see if the Town will vote to authorize its Selectmen to sell at public auction, any real estate acquired by the Town through Tax Collector's Deeds, and until such sale is made to administer such property in the interests of the Town.
25. To see if the Town will vote to accept, ratify and confirm the reports of Agents, Selectmen, Auditors, Committees and all other Town Officers as contained in the Annual Report of said Town for the year ending December 31, 1950.
26. To transact any other business that may legally come before this meeting.
