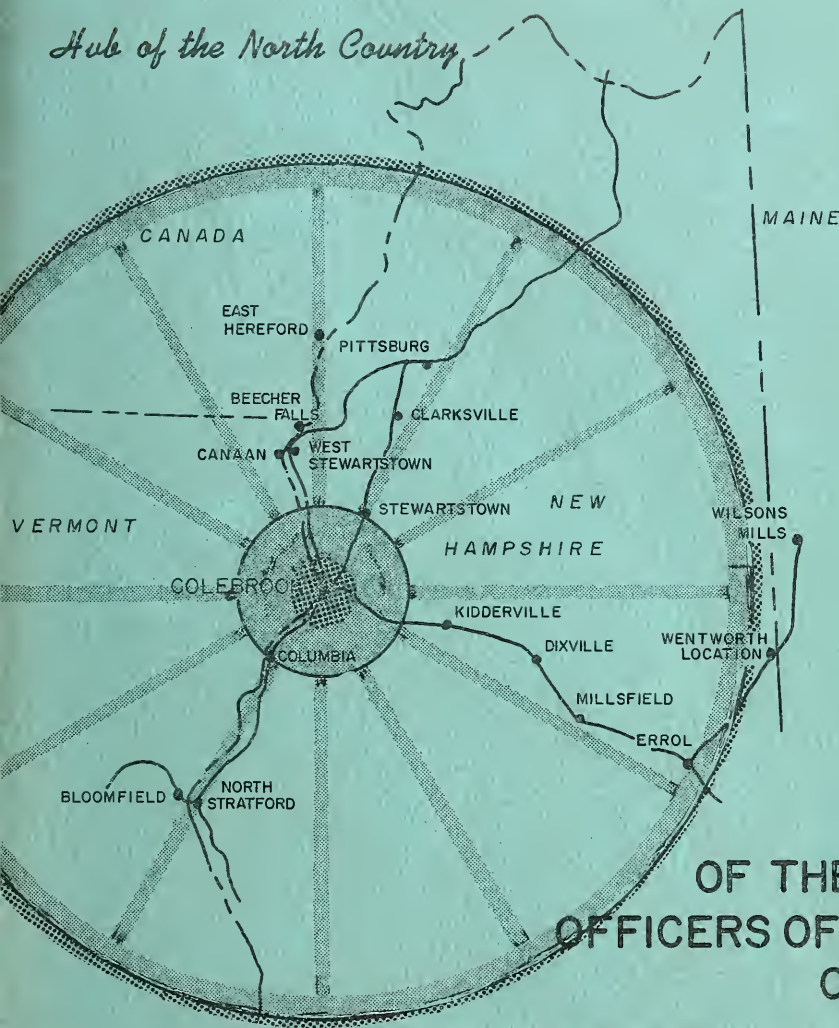

THE STATE OF NEW HAMPSHIRE

To the inhabitants of the Town of Colebrook, in the County of Coos, in the State of New Hampshire, qualified to vote in town affairs:

You are hereby notified to meet at the Colebrook School Gymnasium in said Town of Colebrook on Tuesday, the 6th day of March, next, at ten o'clock in the forenoon, to act upon the following subjects:

1. To bring in your ballots for the election of Town Officers to be elected by ballot for the Town of Colebrook for the ensuing year.
2. To act upon all of the following articles contained in this warrant.
3. To see if the Town will instruct its Selectmen to appoint all other Town Officers as required by law.
4. To see what sum of money the Town will vote to raise for the General Government Expenses for the ensuing year.
5. To see what sum of money the Town will vote to raise for Police for the ensuing year.
6. To see what sum of money the Town will vote to raise for Civilian Defense for the ensuing year.
7. To see what sum of money the Town will vote to raise and appropriate for the operating expenses of Ambulance District A-1.
8. To see what sum the Town will vote to raise and appropriate to pay all or part of the balance of its pro rata share of the cost of construction of the Upper Connecticut Valley Hospital.
9. In the event that under the foregoing article it is voted to raise and appropriate the full balance of the Towns commitment toward the construction of the Upper Connecticut Valley Hospital, to see if the Town will vote to authorize the Selectmen to execute Bonds or serial Notes, on such terms as said Selectmen may deem to be in the best interest of the Town, for said purpose.
10. To see what sum of money the Town will vote to raise as a contribution for the services of the Upper Connecticut Valley Mental Health Service.
11. To see what sum of money the Town will vote to raise for the Care, Removal and/or Replacement of Trees.
12. To see what sum of money the Town will vote to raise for maintenance of Summer and Winter Roads for the ensuing year.
13. To see what sum of money the Town will vote to raise for the General Expense of the Highway Department for the ensuing year.
14. To see what sum of money the Town will vote to raise for Street Lighting for the ensuing year.

15. To see if the Town will raise the sum of \$1,029.30 for maintenance, construction or reconstruction of Class V Highways, in the event, the State will contribute \$6,862.01.
16. To see if the Town, will vote to remove the snow from the business area of the village, defining the area to be cleared, and to raise money for the same.
17. To see what sum of money the Town will vote to raise for Plowing and Sanding Sidewalks, for the ensuing year.
18. To see what sum of money the Town will vote to raise for support of the Town Library for the ensuing year.
19. To raise such sums of money as may be necessary for the support of the Town Poor for the ensuing year.
20. To raise such sums of money as may be necessary for Old Age Assistance for the ensuing year.
21. To see if the Town will vote to raise the sum of \$300.00 for the observance of Memorial Day and care of the Monument Lot.
22. To see what sum of money the Town will vote to raise for Hydrant Rental for the ensuing year.
23. To see what sum of money the Town will vote to raise for the care of Cemeteries for the ensuing year.
24. To see what sum of money the Town will vote to raise and appropriate to the Colebrook and North Country Chamber of Commerce for the purpose of publicizing and promoting by advertising folders and otherwise, the Town and North Country.
25. To see if the Town will vote and appropriate the sum of \$840.47 to the White Mountain Region Association, being .07c per \$1,000.00 of equalized valuation, for the purpose of issuing and distributing printed matter and advertising and otherwise publicizing the advantages of the Town, in cooperation with the other 45 towns in the region.
26. To see if the Town will vote to raise the sum of \$1,500. for the construction of sidewalks in accordance with the vote at the 1951 Town Meeting for the ensuing year.
27. To see what sum of money the Town will appropriate for Cleaning Streets in the business area this summer and to authorize the Selectmen to withdraw the amount voted from the Parking Meter Fund.
28. To see what sum of money the Town will vote to raise for Tarring Streets.
29. To see what sum of money the Town will raise for Street Construction, and to direct the Selectmen to place any unexpended balance in a special fund to be used for other streets in later years.
30. To see what sum of money the Town will vote to raise for maintenance of the Town Dump for the ensuing year.
31. To see what sum of money the Town will vote to raise and appropriate for the purchase of new equipment, and to authorize the withdrawal of such sum for this purpose from the Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972.

32. To see what sum of money the Town will vote to raise and appropriate for the operation and construction of the Sewer and Water Departments and direct the Selectmen to place any unexpended balance in a Special Fund to be used for the same purpose in later years.
33. To see what sum of money the Town will vote to raise to pay on the principal of the bond issue for the Sewerage Facilities.
34. To see if the Town of Colebrook will vote to raise and appropriate a sum not to exceed Twenty Thousand Dollars (\$20,000.00) for the purpose of financing and constructing additional facilities to treat effluent and provide aeration equipment at the existing treatment works; and to authorize the Selectmen to raise not exceeding Sixteen thousand Dollars (\$16,000.00) of said sum by the issuance of Serial Bonds or Notes under and in compliance with the provisions of the Municipal Finance Act (Chapter 33 of the New Hampshire Revised Statutes Annotated, 1955, and any amendments thereto); and to authorize the Selectmen to issue and negotiate such Bonds or Notes and to determine the rate of interest thereon, and to take such other actions as may be necessary to effect the issuance, negotiation, sale, and delivery of such Bonds or Notes as shall be in the best interests of the Town of Colebrook; and further to authorize the Selectmen to accept any Federal and State of New Hampshire funds which may be available for this project and to pass any vote relating thereto.
35. To see what sum of money the Town will vote to raise and appropriate for the resurfacing of the Hospital Road and to authorize the withdrawal of such sum for this purpose from the Revenue Sharing Fund established under the provisions of the State and Local Assistance Act of 1972.
36. To see if the Town will vote to raise and appropriate the sum of Six Thousand Dollars (\$6,000.00) from the Revenue Sharing Trust Fund to be transferred to the capital reserve fund known as the Special Dump Fund established at the 1969 Town Meeting and augmented by further appropriation under Article 34 of the Warrant for the Annual Town Meeting of 1972.
37. To see what sum of money the Town will vote for the use of the Town Planning Board for the ensuing year.
38. To see if the voters will authorize the Selectmen to expend any surplus which may remain from monies raised and appropriated under Article 36 at the 1972 Town Meeting for repair of the Pleasant Street bridge, for repairing and rebuilding other bridges within the Town of Colebrook.
39. To see if the Town will raise and appropriate the sum of Forty-Five Thousand Dollars (\$45,000.00) for the purpose of renovation of the Town Hall and purchase of furnishings and equipment for same and to authorize the withdrawal of the amount not exceeding Ten Thousand Dollars (\$10,000.00) for this purpose from the Revenue Sharing Fund established under the State and Local Assistance Act of 1972, the balance, the sum of not exceeding Thirty-Five Thousand Dollars (\$35,000.00), to be raised by the issuance of serial Bonds or Notes under and

in compliance with the provisions of the Municipal Finance Act (Chapter 33 of the New Hampshire Revised Statutes Annotated, 1955, and any amendments thereto) and to authorize the Selectmen to issue and negotiate such Bonds or Notes and to determine the rate of interest thereon and to take such other actions as may be necessary to effect the issuance, negotiation, sale and delivery of such Bonds or Notes as shall be in the best interests of the Town of Colebrook.

40. To see if the Town will vote by ballot to authorize the Selectmen to have taxable property in the Town reappraised by the State Tax Commission and to raise and appropriate the sum of Fifteen Thousand Dollars (\$15,000.00) in part payment for said purpose, any unexpended balance of said appropriation to be placed in a capital reserve fund for future expenditures for said purpose and to further authorize the Selectmen to withdraw this sum of Fifteen thousand dollars (\$15,000.00) from the Revenue Sharing Fund established under the State and Local Assistance Act of 1972.
41. To see what sum of money the Town will vote to raise and appropriate for perambulation of boundaries of the Town of Colebrook as required by Revised Statutes Annotated, Chapter 51.
42. To see if the Town will vote to discontinue as a Class V Town Highway that portion of the "Old Fairgrounds Road" which leads from N. H. Route 145 to the premises now or formerly owned by Grace Chase.
43. To see if the Town will vote to amend Article IV, Section 8, of the Town Zoning Ordinance so that it will read as follows:

"Signs: No outdoor advertising structure may continue as a nonconforming use for more than two years after effective date of this ordinance unless it was placed/erected upon the premises prior to said effective date, or unless it is designed to direct attention to a business or profession conducted on the premises on which the sign is actually erected."

(Inserted by Petition.)

44. To see if the Town will vote, pursuant to R. S. A. 238:2 (by separate vote on each), to discontinue subject to bars and gates the following Class V highways, as shown and numbered on a certain highway map of Colebrook dated 1936, said map now being available for inspection at the Town Clerk's Office:
 - (a.) Road No. 12 known as the Wilbur Hicks road.
 - (b.) Road No. 25 known as the Cross road or the Hanson road.
 - (c.) Road No. 27 known as the Bear Rock road and being that portion of this road North of the Frederick Rainville buildings.
 - (d.) Road No. 37 known as the Belvelle road.
45. To see if the Town will vote to give free use of the Town Hall to public schools in said Town for school purposes including heat, lights, and janitor services whenever same does not conflict with best interest of the Town,

for the ensuing year.

46. To see if the Town will vote to give free use of the Town Hall to non-profit organizations, including heat, lights, and janitor services, whenever same does not conflict with the best interest of the Town and at the discretion of the Selectmen, for the ensuing year.
47. To see if the Town will vote to authorize the Selectmen to borrow the money to defray the expenses of the Town in anticipation of taxes, for the ensuing year.
48. To see if the Town will vote to authorize the Selectmen to sell at public auction any real estate acquired by the Town through Tax Collector's deeds, or owned by the Town or any agency thereof, and until such sale is made, to administer the property in the best interest of the Town.
49. To see if the Town, will vote to accept, ratify and confirm the reports of Agents, Selectmen, Auditors, and all other Town Officers, as contained in the Annual Report of the said Town for the year ending December 31, 1972.
50. To Transact any other business that may legally come before this meeting.

Money received under this "State and Local Fiscal Assistance Act of 1972" can be spent by the Town for certain capital expenditures and "ordinary and necessary" maintenance and operating expenses. The Selectmen intend to recommend at the 1973 Town Meeting that these funds be used in areas of the Budget which will help reduce the overall Tax burden of the Taxpayers.

SUMMARY PROGRAM OF THE WHITE MOUNTAINS REGION ASSOCIATION 1972 - (35th Year)

The officers and directors held two meetings to re-assess the goals and projects of the Association to make them more meaningful for the 1970's. Out of these two, eight hour sessions came agreements on five programatic objectives. They were the need to insure a quality environment, orderly development, improved public transportation facilities, vocational training, and the need for a community college. The first objective has received the most attention since these sessions were held. In this regard the Association sponsored a workshop on air pollution in Berlin.

The Association has spoken out on the need to preserve the small family farms and, thus, it has actively supported the Open Space Bill, HB44. The Bill permits selectmen to tax land upon current use instead of its potential value. The Association spoke out in support of this Bill at a senate hearing in Concord and contacted the state senators and representatives in the region notifying them of the Association's position on the subject.

The Association sponsored a very successful sewage conference in Waterville Valley. Billed as a "sharing of ideas" the conference dealt with some new concepts in sewage treatment such as combining wood wastes with sewage to make fertilizer.

The Association organized a hearing on regional planning in Twin Mountain and worked with the Town of Carroll in setting up what turned out to be the most successful snowmobile hearing in the State.

Finally, as an integral part of its annual meeting the Association, held a very exciting panel discussion on "Development/Environment." Gov. Frank W. Sargent of Massachusetts, a former commissioner in the Department of Natural Resources there, addressed the group following the annual dinner on a theme in keeping with the theme of the meeting, "Best Use of Our Natural Resources."

Non-environmental Association activities for the past year included: help in preparing background information for the Berlin and Whitefield Airports for the hearings in Concord before the Civil Aeronautics Board; creation of a new Association logo and a very successful fall foliage shunpike folder; continued promotion of the off season through news releases and the sponsorship of several canoe races, the most ambitious and successful of which was the New England Canoe Slalom held in Campton. Also, the Association assisted a group in Berlin develop a plan for a hotel trade learning course.

In preparation is a canoeing folder, which, if enough advertising can be sold, should be out well before spring of 1973.

Organized a meeting and prepared a statement regarding the then proposed visitor's information center on the Kancamagus Highway with the U. S. Forest Service.

Presented awards to 4-H Clubs in both Coos and Grafton Counties.

Appeared on six radio programs, attended one travel show in Harrisburg, Pennsylvania, and spoke before several groups in the Region.

Inquiries for the year totaled 5,501.

Wrote 45 news releases and 126 personal letters.

Also wrote five newsletters, "Recreation Pressures in the White Mountain National Forest," "New Yeah's Resolution!," "Our Open Space", one on the "Sewage Conference", and a personal newsletter by John P. Wilson.

REPORT OF THE FOREST FIRE WARDEN AND DISTRICT CHIEF

In New Hampshire, forest fire control is a cooperative State-Town program. The Town Forest Fire Warden, appointed by the Director, Division of Resources Development upon recommendation of the Selectmen and the State's District Forest Fire Chief is responsible for fire suppression and other related duties. The State shares equally with the Town in the cost of most forest fires, except illegal and careless fires, which are charged to the responsible party. The State further provides fire detection services, prevention programs, fire training for town wardens and crews, and back up equipment for fire suppression.

By authority of the State, the Town Forest Fire Warden controls all outside burning in his town except backyard cooking fires. Any person wishing to kindle a fire when the ground is not covered with snow must obtain a fire permit, free of cost, from the Town Forest Fire Warden. No permits will be issued for fires between 9:00 a.m. and 5:00 p.m. unless it is raining, except for commercial purposes.

Please be careful when using fire, remember it can be an extremely useful tool when under control but once allowed to run wild it can become a disastrous and devastating force. Only you can prevent a forest fire.

REPORT OF SERVICE RENDERED IN THE TOWN OF
COLEBROOK 1972

Mental health services for the town of Colebrook were significantly expanded during the past year - both counseling individuals and families, and services to children in the Colebrook schools.

Seventy-seven Colebrook residents received counseling, either at the Colebrook office or in their homes, and the schools have been visited frequently to develop plans for assisting students with problems. Among the services being given to students are psychological evaluations; individual counseling; counseling with families, either at school, home or in the clinic office. Plans for helping the child in the classroom are discussed with the teacher and with other helping agencies such as special education and the school nurse.

Because the agency is locally based and operated, patients can be helped quickly, with the result that very few residents need to go on to New Hampshire Hospital or other resources out of the area.

Colebrook's contribution to Upper Connecticut Valley Mental Health Service helps in obtaining matching funds from state and other sources; and it insures that the staff is consistently available when needed. Costs are kept at a minimum without impairing quality of care; and per capita costs for our area are far below those of other rural mental health agencies.

Upper Connecticut Valley Mental Health Service, Inc. meets all state and professional standards for such programs and is a full member of the New Hampshire Association of Community Mental Health Agencies.

Our staff is prepared to respond to your requests.

REPORT OF SERVICES

With the finish of 1972 and the end of our second year of providing service you should know what health services have been rendered to you and yours by the many health team workers of Upper Connecticut Valley Hospital.

The hospital served 941 of you as in-patients and 1,850 of you as out-patients. Ninety-eight new citizens were born there. In addition to a full range of services 1971 it added a coronary care unit in July and a Physical Therapy Dept. in October.

Your hospital working with selectmen helped to form first an Ambulance Coordinating Board which led to an official ambulance district A-1, the second one in New Hampshire with three companies in Pittsburg, Colebrook, Stratford. Using the hospital line of credit, gifts from generous donors, (towns and individuals) and state funds the district now has or will have by the end of January capital equipment of four ambulances and a complete radio system valued at over \$25,000.00 It's all paid for except for \$7,000.00. To operate the system the fees were not enough and the selectmen agreed to ask for tax support in 1973 at the rate of \$1.25 per person. It now appears that the service can come within \$2,400.00 of breaking even without tax help. If we can get contributions or promise of them prior to town meeting, we will withdraw our article requesting tax support at every town meeting.

Your hospital association sponsored a home health agency known as CONVALESCE which opened on December 1, 1972. It provides temporary nursing, physical therapy and other health services in the home. It is located in a rent free office in the hospital and adds greatly to the range of health services available to you. CONVALESCE will not be asking you for tax support in 1973.

Your hospital association has just began a years study to see if a prepaid group medicine practice using our local physicians as the base could work in the Colebrook region. You will be contacted during 1973 for your thoughts and ideas about this new way of delivering more health care at a lower cost to all concerned. This study is federally funded and will not ask for any local tax dollars.

Your doctors of the area together with the hospital trustees and administration have been working actively the last six months on a search for new qualified doctors to locate full time here. The effort is encouraging and we have great hopes for results within six months.

Your auxiliary (the second largest in New Hampshire) has already proved its great value in taking the hospital story from the inside to all who will listen - also they raised and donated over \$5,200.00 toward radio equipment.

Your unpaid Trustees and Directors have met every month, sometimes more often to offer their talent and experience.

A new enterprise like this has a rocky road to go for the first five years. Two years have passed. The road is still rough but getting smoother. We look forward to the remaining towns to join the eight that have paid in full their cost share of constructing the hospital. The hospital has not and hopefully will not be asking you for tax support to operate the hospital.

This is only true because of the huge amount of support, ideas, dollars from a large number of you.

This just couldn't happen in the city; here we should never take it for granted. We don't - but we're sure glad all of you are the way you are.
